THE 2030 AGENDA - KEY FACTS

- The 2030 Agenda was adopted in 2015 by the 193 member states of the United Nation General Assembly.
- It commits all signatory countries and different actors to eradicate poverty and achieve sustainable world-wide development by 2030, ensuring that no one is left behind.
- It contains 17 Sustainable Development Goals (SDGs) in order to build a world that meets the needs of present and future generations.
- It requires efforts by both state and non-state actors and their dialogue, cooperation and coordination, as well as the involvement of all citizens

The 2030 Agenda addresses multiple development objectives simultaneously, balancing economic, social and environmental sustainability and recognizing that an intervention in one area will affect the outcomes in others. That is why the 2030 Agenda is unique, universal, applying to all countries and actors and deserving dedication from all of society.

"The 'leave no one behind' (LNOB) principle of the 2030 Agenda shines the spotlight on the poorest and most vulnerable people and calls for all stakeholders to intensify their efforts to narrow existing gaps between population groups."

WHAT DO WE WANT TO ACHIEVE?



FACILITATE DIALOGUE: We aim to establish a society-wide dialogue for defining and implementing SDG-related policy priorities and to create an open space for discussion and consent-building with state actors on different levels.



RAISE AWARENESS: We will raise awareness and build knowledge about SDGs in the Serbian society.



ADVANCE NETWORKING AND COLLABORATION: We will link existing networks and coalitions, provide room for a cross-sector dialogue and support building common attitudes among them.



PROMOTE EXCHANGE AND MUTUAL LEARNING: We aim to strengthen the role of non-state actors and facilitate mutual learning and knowledge exchange of CSOs, businesses, professional associations, research organizations, media and international actors in implementing the SDGs.



ENHANCE MONITORING AND ACCOUNTABILITY: We will jointly support monitoring and accountability by collecting and providing data on SDG implementation.

THE 2030 AGENDA IN SERBIA

- Implementation of the 2030 Agenda benefits all citizens of Serbia and is closely linked with the European Union accession process.
- The Republic of Serbia was involved in the formulation of the SDGs and has been committed to the implementation of the 2030 Agenda since its adoption.
- The Government of the Republic of Serbia is making efforts to contextualize and adapt the SDGs to national needs in line with the ongoing EU accession and related reform processes.
- On behalf of the Serbian Government, coordination of the implementation of the 2030 Agenda is facilitated by the Inter-ministerial Working Group (IMWG).
- The Serbian Parliament deals with the 2030 Agenda through the informal Focus Group for the Development of Control Mechanisms for the Process of Implementation of the Sustainable Development Goals.
- Several CSOs and their networks have been working on the 2030 Agenda either independently or in cooperation with relevant UN and international mechanisms.
- The SDGs implementation process in Serbia could be further strengthened by identifying priorities and integrating the SDGs in the strategic framework on national and local level, by increasing monitoring and accountability through setting national targets and by building a link between the SDGs and the budgetary processes.

WHAT ARE WE DOING TO ACHIEVE OUR OBJECTIVES?

The Platform was launched at a conference held on March 4, 2020 in Belgrade, which gathered representatives of international organizations, UN agencies, the government, the business community and academia, as well as a large number of civil society organizations and the media. On that occasion, the work principles of the Platform at the national and local level were presented.

Implementing actions and publishing information in support of SDGs implementation in Serbia, including a report on Serbian society's evidence-based development priorities, annual monitoring reports, policy recommendations, annual conferences and other activities

HOW THE "SDGs FOR ALL PLATFORM" WORKS

The indivisible nature of the SDGs means that we should look at the 2030 Agenda as a system of interlinked and mutually dependent goals – with the overall objective to achieve sustainable development 'leaving no one behind'. For the purpose of a more efficient facilitation of the dialogue process, the Platform is structured in three closely intertwined pillars. While each pillar is managed by a pillar coordinator dedicated to a group of primary SDGs corresponding to one of the three dimensions of sustainable development (social sphere – environment – economy), some SDGs, as well as the 'leave no one behind' (LNOB) principle, will be part of the dialogue within each and between all three pillars.
